 - (a) He / Her residence should be in the Headquarte of the state or within the district for which he /
she seeks recognition.
 - (b) The Correspondent of Newspaper or News Agency should be drawing the prescribed wage in
the category of his / her Newspaper or News Agency as per the Wage Board recommendation
for working Journalist and the relevant notification of the Minister of Labour, Government of
India.
 - (c) At the time of application, he/she should have spent at least five consecutive years in the
profession of Journalist and should be a person of sufficient experience and standing to be able
to discharge his / her duties in a competent and responsible manner.
 - (d) If he / she is a stringer / part time Press Correspondent working with one or more News Paper
or Agency / Agencies he / she should be recipient of retainer's fee under Wage Board Regulation.

(e) When a recognised correspondent ceases to represent a News Agency or News Paper on behalf of which he / she is recognised, the fact should be brought to the notice of the DIPR, Assam, in writing by the correspondent as well as by the Editor concerned within 15 days, failing which necessary action will be taken as per provision of the Assam Press Correspondents (Accreditation / Recognition) Rule, 1989.

(f) Application for recognition shall be made by a Correspondent through the Editor / Chief of Bureau of the Newspaper or News Agency in which he is employed to the DIPRO of the district for which he / she seeks recognition.

(g) The application should be accompanied by

- (i) Two copies of recent Stamp Size Photographs duly signed at the back by the Editor.
- (ii) Copy of appointment and posting letter, duly attested by the Editor.
- (iii) Experience Certificate in Original from the Editor along with his recommendation for recognition.
- (iv) Certificate from concerning District Information & Public Relations Officer.
